

Coronavirus Aid, Relief, and Economic Security (CARES) Act Emergency Financial Aid Grant to Students

Update on CARES Act Funding Eligibility

In the <u>Law suit of Oakley vs. DeVos</u>, California Community Colleges Chancellor's Office received a preliminary injunction against the US Department of Education (DOE) regarding the distribution of CARES Act Emergency Aid to students. The Coronavirus Aid, Relief, and Economic Security Act (CARES Act) grants COVID-19 relief funds to college students, but the DOE guidance on the distribution of those funds excluded some students from receiving this much needed aid. The DOE <u>FAQ</u> regarding student eligibility requirements outlines how funds can be allocated, which effectively prevented certain students - undocumented, non-credit, credential only - to name a few, from receiving economic relief during the pandemic. This recent court injunction removes all student eligibility conditions. Given this, the Palo Verde College District is responsible for distributing these funds to our students is taking steps to reassess all applications it has received to date from both Round 1 of CARES Act Funding, and the second round of applications being submitted for this aid, to support those students who were previously thought to be ineligible for CARES resources.
