- This is an extension of the dual enrollment agreement that is already in place between PVC and Needles unified. This agreement would enable the high school teachers who meet all minimum qualifications of the California Community College system to offer college courses within the school hours and premises. Typically, these would be scheduled for the 6th and 7th period and should be open to the public. These instructors would be evaluated by the college and follow our course outline of records and SLO assessments. After your review, feedback and confirmation, there would be a presentation to the Unified Board sometime in December followed by our B.O.T approval early next year. This agreement would go into effect earliest by Fall 2021 and would enable more students to enroll and complete the first-year math/English courses before choosing to attend PVC.
