 - ATH 100: F2F – NEW Pre-Season Conditioning for Basketball B. Thieboux

- Discussions of the ATH courses:
 - ATH 100, 101, 102, 103 and 104 templates were modeled after similar courses at Los Rios Community College since they have an ongoing program. ATH 100- All students must go through this course before the students are able to be on the team. This course needs to be offered spring 2018 in order for the basketball team to start fall 2019. Brain did state that there are some language changed that needs to be addressed on the CORs so there is more of a differentiation with the courses. Irma stated that there should not be a restriction as ATH 100 has to be taken in order to be on the team. This will be researched and revised at a later date if needed. Shelley mentioned that we need to keep in mind that the students can only have 350 contact hours for 4 semesters. 175 dedicated to the sport and 175 dedicated to the conditioning. Diana Mendez stated that these courses will not count towards the students financial aid check due to them not being part of a program. She asked that once we offer these courses to let the students know that they will need to make sure they have 12 units before taking this class if they want the full time status.
