A. New/Revised Courses and Programs

1. CWE 140 Occupational Work Experience Carina Huynh

B. SB 1440/TMC for Psychology Hortensia Rivera

It was moved by Kevin Eoff and seconded by Brian Thiebaut to approve the TMC for Psychology as amended by the committee. All members in favor; motion carried.

This TMC will be sent to the Board of Trustees for approval on February 15. It will then be forwarded to the Chancellor's Office for approval.
